Frequently Asked Questions

Where is Safran E&P Mexico located?

 Safran Electrical & Power Mexico S.A. de C.V. "Safran E&P Mexico" is a Mexico based company located at Calle Nicolas Gogol #11322, Complejo Industrial, Chihuahua C.P. 31136 in Chihuahua City, Mexico.

What items/commodities does Safran E&P Mexico manufacture?

 Safran Electrical & Power Mexico makes electrical wiring systems for civil and military aerospace programs.

If we ship to Safran E&P Mexico, are we the USPPI and responsible exporter party?

 Yes, Safran E&P Mexico does not have an order party in the US and requires that US suppliers act as USPPI.

Where can information be found regarding our responsibility as an exporter to Safran E&P Mexico?

• The exporter and licensing responsibilities of the exporter are enumerated in the Purchasing Long Term Agreements and in the Purchase Order Terms and Conditions.

If we ship to Labinal at El Paso, Texas, why can't **Safran E&P Mexico's US affiliate** be the exporter / USSPI?

 Neither Safran E&P Mexico nor its US affilliate maintain a presence in El Paso. Safran E&P Mexico's agent (UPSSCS) accepts components not requiring license on behalf of Safran E&P Mexico at El Paso, TX. Such exports are ROUTED EXPORTS.

Is Safran E&P Mexico able to file EEI data with US CBP?

- The supplier must file the EEI information or you may ask UPSSCS/Safran E&P Mexico to assist you with providing the proper EEI information to US Customs.
- In the latter case, you the supplier must provide to UPSSCS (Safran E&P Mexico's agent) a power of attorney.
- In either scenario, the supplier is responsible for obtaining AES filings from UPSSCS and verifying the accuracy.

If we (supplier) don't want a third party (UPSSCS) filing our EEI data, may we file our own EEI data?

 Yes. As USPPI and the responsible exporter, you the supplier/export have the authority to choose to file your own EEI data and not hand over responsible party to UPSSCS.

Can Safran E&P Mexico's US affiliate export to Safran E&P Mexico on our behalf?

 No. Labinal LLC is a US <u>manufacturing</u> facility which will not export on behalf of distributors/suppliers to Safran E&P Mexico

Do export-controlled shipments which require Department of State or Department of Commerce licensing require special treatment?

- Special care is required to avoid co-mingling of NLR and Export Controlled items. Safran
 E&P Mexico does not accept ITAR items at EI Paso. ITAR items must be shipped according
 to SHIPPING INFORMATION -EXPORT CONTROLLED SHIPMENTS provided in this
 document.
- Additionally, Safran E&P Mexico does not accept at El Paso any EAR 600 Series military items requiring a Dept. of Commerce license. Such items should be exported as described in SHIPPING INFORMATION –EXPORT CONTROLLED SHIPMENTS
- All items NOT requiring an export license may be shipped to Safran E&P Mexico (c/o Rio Bravo@ El Paso). Please refer to additional information for NLR shipments in the section of this document titled SHIPPING INFORMATION – "NLR" SHIPMENTS

SPECIAL NOTES:	Note: Rio Bravo International Services and UPS Supply Chain Solutions will not process any shipments in El Paso, Texas that require an export license. All shipments received by Rio Bravo International Services must be No-License-Required "NLR Please contact your Labinal buyer immediately, if it is determined at any point during the procurement or delivery process that the item requires an export license for export to Mexico.

	To avoid business disruption, please have export licenses approved at least two weeks in advance of the planned ship date to Safran E&P Mexico.
	Currently, Safran E&P Mexico does not manufacture any items under ITAR Jurisdiction. However, Safran E&P Mexico does manufacture several military items under the new EAR 600 Series of Military items. Subsequently, all licenses required for military items to be authorized for export to Safran E&P Mexico must be submitted and approved by the US Department of Commerce, Bureau of Industry and Security http://beta-www.bis.doc.gov/
